The form is available on the CAA's website, www.canadianarbitrationassociation.ca, or by calling CAA Case Filing Services at 1-800-856-5154. You should attach a copy of this arbitration provision, which will remain available online. If you demand arbitration, you must send a copy of the form or other demand, by Canadian Certified Mail, addressed to: All Ways Inspired™, Attention: Legal Department, 652 Queensland Drive SE, Calgary, AB, Canada, T2J 4G7. If All Ways Inspired™ demands arbitration, you will be sent a copy of the form or other demand, by Canadian Certified Mail, at the most current postal address that All Ways Inspired™ has for you in its records. If your claim is for less than \$10,000, All Ways Inspired™ will pay all of the CAA's administrative fees and the arbitrator's fees, including the initial filing fee. If your claim is for more than \$10,000, and applicable law limits the amount of arbitration fees payable by you, All Ways Inspired™ will pay all of the CAA's administrative fees and the arbitrator's fees in excess of this limitation. Except as otherwise provided by applicable law, each party will remain solely responsible for their own attorneys' fees and expenses incurred in connection with the arbitration.
